

Major achievements and challenges observed in the last two years

Implementation of policies on gender inclusion in Disaster Risk Management and GBV prevention and management, including increased partnerships between government and stakeholder agencies on gender mainstreaming and women's involvement

Increased capacity development on gender inclusion, GBV prevention and management, and minimum standard for Sexual Reproductive Health in disaster emergency response

Increased focus on developing guidelines and assessment tools for sex age and diversity disaggregated data, as well as increased evidence and documentation on good practices on gender and social inclusion

Increased opportunities for discussion on women's meaningful participation and leadership in disaster risks reduction and disaster management
